What is the overall <a href="#">deductible</a> ?	<b>\$6,400</b> Individual / <b>\$12,800</b> Family for Tier 1 - preferred and Tier 2 - standard <a href="#">network</a> services. There is no coverage for non-network services.	Generally, you must pay all of the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the <a href="#">plan</a> , each family member must meet their own individual <a href="#">deductible</a> until the total amount of <a href="#">deductible</a> expenses paid by all family members meets the overall family <a href="#">deductible</a> .
Are there services covered before you meet your <a href="#">deductible</a> ?	Yes. <a href="#">Preventive care</a> and preventive prescriptions from <a href="#">network providers</a> are covered before you meet your <a href="#">deductible</a> .	This <a href="#">plan</a> covers some items and services even if you haven't yet met the <a href="#">deductible</a> amount. But a <a href="#">copayment</a> or <a href="#">coinsurance</a> may apply. What is the <a href="#">out-of-pocket limit</a> for this <a href="#">plan</a> ?	<b>\$6,900</b> Individual/ <b>\$13,800</b> Family for Tier 1 - preferred and Tier 2 - standard <a href="#">network</a> services. There is no coverage for non-network services.	The <a href="#">out-of-pocket limit</a> is the most you could pay in a year for covered services. ### Does this plan provide Minimum Essential Coverage? Yes.
