What is the overall <a href="#">deductible</a> ?	<b>\$2,200</b> Individual / <b>\$4,400</b> Family. <a href="#">In-network</a> and <a href="#">out-of-network deductibles</a> combined.	Generally, you must pay all of the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the policy, the overall family <a href="#">deductible</a> must be met before the <a href="#">plan</a> begins to pay.
Are there services covered before you meet your <a href="#">deductible</a> ?	<b>Yes.</b> <a href="#">Preventive care</a> , <a href="#">preventive</a> prescriptions and prenatal care from <a href="#">in-network providers</a> .	This <a href="#">plan</a> covers some items and services even if you haven't yet met the <a href="#">deductible</a> amount. But a <a href="#">copayment</a> or <a href="#">coinsurance</a> may apply.
