Important Questions	Answers	Why This Matters:
What is the overall deductible ?	\$0 at Indian Health Care Provider (IHCP) or with IHCP referral at non-IHCP; \$7,000 Individual / \$14,000 Family for non-IHCP Tier 1 - preferred and \$7,200 Individual / \$14,400 Family for non-IHCP Tier 2 - standard network services. There is no coverage for non-network services. Tier 1 non-IHCP preferred deductible applies to non-IHCP Tier 2-standard deductible . Network deductible will not exceed Tier 2 limit.	Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. If you have other family members on the plan , each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible .
Are there services covered before you meet your deductible ?	Yes. Preventive care , preventive prescriptions and copay services from non-IHCP network providers are covered before you meet your deductible .	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive services without cost sharing and before you meet your deductible . Are there other deductibles for specific services?	No.	You don't have to meet deductibles for specific services.
What is the out-of-pocket limit for this plan ?	\$8,300 Individual/ \$16,600 Family for non-IHCP Tier 1 - preferred and \$8,550 Individual/ \$17,100 Family for non-IHCP Tier 2 - standard network services. There is no coverage for non-network services. Tier 1 non-IHCP preferred out-of-pocket applies to non-IHCP Tier 2-standard out-of-pocket. Network out-of-pocket will not exceed Tier 2 limit.	The out-of-pocket limit is the most you could pay in a year for covered services. If you have other family members in this plan , they have to meet their own out-of-pocket limits until the overall family out-of-pocket limit has been met.
What is not included in the out-of-pocket limit ?	Premiums , balance billing charges and health care this plan doesn't cover.	Even though you pay these expenses, they don't count toward the out-of-pocket limit .
Will you pay less if you use a network provider ?	Yes. Visit www.medica.com/SearchInsure or call 800-918-6165 (TTY:711) for a list of network providers .	This plan uses a provider network .
