What is the overall <u>deductible</u> ?	\$0 at Indian Health Care Provider (IHCP) or with IHCP referral at non-IHCP; \$1,400 Individual / \$4,200 Family for non-IHCP Tier1 - preferred network and Tier 2 - standard network services. There is no coverage for non-network services.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. Are there services covered before you meet your deductible?
