What is the overall <u>deductible</u> ?	<b>\$0</b> at Indian Health Care <u>Provider</u> (IHCP) or with IHCP <u>referral</u> at non-IHCP; <b>\$6,800</b> / Individual or <b>\$13,600</b> / Family for non-IHCP <u>network</u> services. Are there services covered before you meet your deductible?	Yes.
