What is the overall <u>deductible</u> ?	\$7,500 Individual / \$15,000 Family for Tier 1 - preferred and \$7,700 Individual / \$15,400 Family for Tier 2 - standard network services. There is no coverage for non-network services. Tier 1 preferred deductible applies to Tier 2-standard deductible. Network deductible will not exceed Tier 2 limit.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .			
Are there services covered before you meet your deductible?	Yes. Preventive care, preventive prescriptions and copay services from network providers are covered before you meet your deductible.
