Important Questions	Answers	Why This Matters:
What is the overall deductible?	\$6,500 Individual / \$13,000 Family for Tier 1 - preferred and \$7,500 Individual / \$15,000 Family for Tier 2 - standard network services. There is no coverage for non-network services. Tier 1 preferred deductible applies to Tier 2-standard deductible. Network deductible will not exceed Tier 2 limit.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your deductible?	<b>Yes.</b> Preventive care, preventive prescriptions and copay services from network providers are covered before you meet your deductible. Are there other <u>deductibles</u> for specific services?	No.	You don't have to meet deductibles for specific services.
What is the <u>out-of-pocket limit</u> for this <u>plan</u> ?	\$8,700 Individual / \$17,400 Family for Tier 1 - preferred and \$8,700 Individual / \$17,400 Family for Tier 2 - standard network services. There is no coverage for non-network services. Tier 1 preferred out-of-pocket applies to Tier 2-standard out-of-pocket. Network out-of-pocket will not exceed Tier 2 limit.	The <u>out-of-pocket limit</u> is the most you could pay in a year for covered services. Do you need a <u>referral</u> to see a <u>specialist</u> ?	No.	You can see the <u>specialist</u> you choose without a <u>referral</u> .
