What is the overall <a href="#">deductible</a> ?	<b>\$750</b> Individual / <b>\$1,500</b> Family for Tier 1 - preferred and Tier 2 - standard <a href="#">network</a> services. There is no coverage for non-network services. Tier 1 preferred <a href="#">deductible</a> applies to Tier 2-standard <a href="#">deductible</a> . <a href="#">Network deductible</a> will not exceed Tier 2 limit.	Generally, you must pay all of the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. Are there services covered before you meet your <a href="#">deductible</a> ?	<b>Yes.</b> <a href="#">Preventive care</a> , preventive prescriptions and <a href="#">copay</a> services from <a href="#">network providers</a> are covered before you meet your <a href="#">deductible</a> . What is the <a href="#">out-of-pocket limit</a> for this <a href="#">plan</a> ?	<b>\$2,650</b> Individual / <b>\$5,300</b> Family for Tier 1 - preferred and Individual / Family for Tier 2 - standard <a href="#">network</a> services. There is no coverage for non-network services. Tier 1 preferred out-of-pocket applies to Tier 2-standard out-of-pocket. <a href="#">Network</a> out-of-pocket will not exceed Tier 2 limit.	The <a href="#">out-of-pocket limit</a> is the most you could pay in a year for covered services.
