What is the overall <u>deductible</u> ?	\$6,800 Individual / \$13,600 Family for network services. There is no coverage for non-network services.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay.
