What is the overall deductible?	\$2,000 individual / \$4,000 family for in-network services. \$9,900 individual / \$29,700 family for out-of-network services.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your deductible?	Yes. <u>Preventive care</u> , preventive prescriptions and <u>copay</u> services from <u>network providers</u> are covered before you meet your <u>deductible</u> .	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. What is the <u>out-of-pocket limit</u> for this <u>plan</u> ?	\$8,700 individual / \$17,400 family for in-network services. Not applicable out-of-network. Does this plan provide Minimum Essential Coverage? Yes.
