Important Questions	Answers	Why This Matters:
What is the overall deductible?	\$7,500 individual / \$15,000 family for Tier 1 - preferred and Tier 2 - standard network services. There is no coverage for non-network services. Tier 1 - preferred deductible applies to Tier 2 - standard deductible. Network deductible will not exceed Tier 2 limit.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your deductible?	Yes. <u>Preventive care</u> , preventive prescriptions and <u>copay</u> services from <u>network providers</u> are covered before you meet your <u>deductible</u> .	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. Are there other deductibles for specific services?	No.	You don't have to meet <u>deductibles</u> for specific services.
What is the out-of-pocket limit for this plan?	\$9,450 individual / \$18,900 family for Tier 1 - preferred and Tier 2 - standard network services. There is no coverage for non-network services. Tier 1 - preferred out-of-pocket applies to Tier 2 - standard out-of-pocket. Network out-of-pocket will not exceed Tier 2 limit.	The <u>out-of-pocket limit</u> is the most you could pay in a year for covered services. If you have other family members in this <u>plan</u> , they have to meet their own <u>out-of-pocket limits</u> until the overall family <u>out-of-pocket limit</u> has been met.

Does this plan provide Minimum Essential Coverage? Yes.

If you are eligible for certain types of Minimum Essential Coverage, you may not be eligible for the premium tax credit.
