What is the overall deductible?	\$1,500 individual / \$3,000 family for network services. There is no coverage for non-network services.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. Are there services covered before you meet your deductible?
